AMS 4.0 is a highly active ammonium sulfate solution. The superior quality spray grade of ammonium sulfate reduces cold water sedimentation and nozzle plugging commonly found with dry ammonium sulfate products. The stable antifoam contained in CNI AMS 4.0 helps prevent foaming during tank mixing.

PRECAUTIONARY STATEMENTS

Tank mixes: Use rate of .25% to 5% or 1 quart to 5 gallons of AMS 4.0 per 100 gallons of spray solution.
