**FUSION 360 SOIL-O** is specifically designed to be used in conjunction with **Iota-O**, however it may be used with organic approved liquid nitrogen fertilizer solutions, microbes and certain minor elements.

**CAUTION:** If **FUSION 360 SOIL-O** should impinge upon foliage, be sure to wash foliage immediately with water. Flush application equipment with water following each application.

### **DIRECTIONS OF USE:**

**Alfalfa:** 5-25 gpa with irrigation.

**Stone Fruit, Nut Crops, Citrus & Olives:** 5-60 gpa with 2-3 maintenance applications of 5 gpa spaced throughout the growing season.

**Vine Crops:** 5-60 gpa with periodic maintenance applications of ~5 gpa spaced 2-3 times throughout the season.

**Vegetable & Field Crops and Berries:** 3-25 gpa with periodic maintenance applications of ~3 gpa spaced 2-3 times throughout the season.

**Tropical Fruits** 3-25 gpa with periodic maintenance applications of ~3 gpa spaced 2-3 times throughout the season.

**Ornamentals:** 1-3 gals per 1,000 sqft with maintenance applications of 1 gal/1,000 sqft in month intervals.
