**2. HAZARDS IDENTIFICATION SUMMARY**

---

**KEEP OUT OF REACH OF CHILDREN – CAUTION.** Harmful if swallowed, absorbed through skin or inhaled. Avoid breathing vapor or spray mist. Remove contaminated clothing before reuse. **4. FIRST AID MEASURES**
