6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Isolate area and keep unnecessary and unprotected personnel from entering. Wear suitable personal protective clothing and equipment as described in Section 8 of this document.

Environmental Precautions: Prevent material from entering public sewer systems or any waterways. Do not flush to drain or soil. Contain contaminated water.

Spill Cleanup: Clean up spill immediately. **If spill is on land:** Absorb spill with inert material (such as dry sand or earth), then vacuum or sweep up material and place in a chemical waste container. Wash area with soap and water. Pick up wash liquid with additional absorbent and place in chemical waste container. **If spill is in water:** Stop the source of the release. Contain and isolate to prevent further release into soil, surface water and ground water. Absorb spill with inert material and remove contaminated water for treatment or disposal.

7. HANDLING AND STORAGE
