#### DIRECTIONS FOR USE

##### RATES:

**CAUTION:** Do not apply CM B-17 directly to seed or at a condition where it will have direct contact with seed. Over application of CM B-17 may cause Boron toxicity. Consult a crop advisor before use to maintain adequate levels for your crop.

**Foliar applications:** Tree and Vines: Apply up to 5 pounds per acre with enough water for thorough coverage.

**Row, Field, Pasture Crops:** Apply up to 3 pounds per acre with enough water for thorough coverage.

**Soil Applications:** Apply 2 to 10 pounds per acre. Apply with enough water or liquid carrier to move product to root zone for proper uptake.

**Dormant and Post Harvest Applications:** Apply at a rate of 2 to 8 pounds per acre with sufficient water for thorough coverage. Apply post harvest to pre-bloom.
