STATEMENT OF PRACTICAL TREATMENT

GENERAL INFORMATION—FS Talyx Aerial is an activator adjuvant specifically formulated to enhance the performance of a wide range of fungicides, and their tank mixes, when applied by aerial application equipment. FS Talyx Aerial combines the proven fungicide activation technology of FS Talyx with phytobland oils and phosphate esters to buffer the spray solution, improve compatibility and enhance deposition of fungicides and insecticides into the target crop canopy. Use FS Talyx Aerial when a phytobland crop oil is required.

APPLICATION RATES

Aerial Applications: Apply FS Talyx Aerial at ½ pint in 2–3 gallons of water per acre.

Apply FS Talyx Aerial at 1 pint in 4–5 gallons of water per acre.

Ground applications: FS Talyx Aerial is not recommended. Instead, use FS Talyx at 1 pint per 100 gallons of spray solution. See FS Talyx label for details

MIXING INSTRUCTIONS—Always mix this product in accordance with the instructions found on the pesticide label concerning adjuvants. In the absence of specific mixing instructions, fill the spray tank 1/2 to 3/4 full of desired water volume. While the water is agitating, add tank mix ingredients in the following order:

1. If foaming is anticipated, use an antifoam/defoamer.
2. Water-soluble packets, dry flowables, and dispersible granule pesticides.
3. Ammonium sulfate, fertilizers and micronutrients.
4. Flowable pesticides.
5. Water-soluble pesticides.
6. FS Talyx Aerial.
7. Emulsifiable concentrate pesticides.
8. Continue agitation and finish filling spray tank to desired level.

STORAGE AND DISPOSAL—Store in original container, in a cool, dry, well ventilated and secure area away from ignition sources (flame or spark). Keep container tightly closed and sealed when not in use. Do not reuse empty container. Rinse container thoroughly, disposing of rinsate and the container in accordance with federal, state and local regulations.
