## 18%Zn-15%Mn-18%S Soluble Fertilizer for Fertigation and Foliar Sprays

### DIRECTIONS

Add NB ZMS to the spray tank when half full. Agitation in the tank will enhance the speed of solubility. Allow extra time for higher rates and areas with extremely cold water to completely solubilize before spraying.

### APPLICATION RATES

Deciduous Fruit and Nut Crops :Apply as pre-bloom and post bloom sprays. Apply 2-8 lbs. per acre. Do not apply during bloom period or under poor drying conditions. Do not apply with other materials that may cause russetting. Do not apply to Anjou pears when above 80°F and/or after fruit turn down.

Citrus(orange, lemons, limes tangerines, grapefruit, tangelos, and other citrus): Apply with sufficient water levels to cover foliage. In low water volume sprays use 1-5 lbs maximum per acre. Apply 2-8 lbs per acre in sufficient water (200 gallons or more per acre). For most tree crops, 3 to 5 applications are sufficient for the growing season. Consult with a crop care advisor for best timing of applications.
