FIRST AID

If in eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.

Residue Application: This product is to be applied at 1.0 to 2.0 gallons per acre with at least 1.0 gallon of UAN (Urea Ammonium Nitrate). The total spray solution volume needs to be 10.0 gallons per acre or higher.

Pre-emergent Application: This product is to be applied at 1.0 to 2.0 gallons per acre. It can be mixed with glyphosate and other herbicides. Adding at least 1.0 gallon of UAN with a minimum spray volume of 10.0 gallons per acre is recommended.

STORAGE AND DISPOSAL

STORAGE: Store product in dark fiberglass or plastic containers out of direct sunlight or UV light. Keep containers tightly closed when not in use.
