## 4. FIRST AID MEASURES

### 4.1 Description of First Aid Measures

### 5. FIRE FIGHTING MEASURES

#### 5.1 EXTINGUISHING MEDIA:

Methods for Clean-Up: Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. After removal flush contaminated area thoroughly with water. Do not allow to enter sewer systems or waterways. Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination. Never return spills to original containers for re-use.

### 7. HANDLING AND STORAGE

#### 7.1 PRECAUTIONS FOR SAFE HANDLING:

Advice on Safe Handling: Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.
