A thin coating of **PINENE S**^{*} solution bonds the pesticide to the crop foliage. This decreases the risk of residue erosion from rainfall or irrigation.

DIRECTIONS FOR USE

Add **PINENE S**[°] to the spray tank as it is filling, with the agitator running. Under most circumstances, apply solution with **PINENE S**[°] a minimum of one hour, during sun up, before an expected rainfall. Sunlight during this time frame is necessary to adhere the bond.
