BENEFICIAL INSECT FEED

GENERAL INFORMATION

HOLD is a special formulation of dry ingredients which are proven to attract and increase the number of predatorial insects within the treated area. HOLD provides beneficial insects with a complete nutritional diet which will keep the predators in the target areas when their normal food sources dwindle. Studies have shown that predatorial insects can increase their numbers ten-fold through reproduction due to the holding power of this product. HOLD is recommended especially when beneficial insects such as predatorial mites or ladybird beetles are to be introduced to an area.

HOLD should be applied when there is moisture on the plant, in late evening or early morning.

HOLD can be applied with non-toxic foliar nutrients and other non-insecticide applications

Do not add this product within 7 days of any pesticide applications that are toxic to predatorial insects.

GUARANTEED ANALYSIS

Crude Protein.....not less than 15.0%
Crude fat.....not less than 0.2%
Crude Ash.....not more than 10.0%
Total Sucrose as Invert.....not less than 52.0%
Total Fiber.....not more than 1.0%

Ingredient Statement:

Sucrose, Lactose, Alkyl Aryl Sulfonate, Sodium, Lignin Sulfonate, Cotton Seed.

DIRECTIONS FOR USE

HOLD should be applied at the rate of 4 to 10 lbs. per acre in 5 to 10 gals. of water. Apply in a swath 40 to 50 feet across and cover only one half the gross acreage needed to be treated. This can be done by skipping every other swath. HOLD can be applied several times prior to the increase of pests.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Follow proper procedures for the disposal of spray solutions. Rnse and dispose of empty container according to approved local practices.

PRECAUTIONARY STATEMENTS

WARNING:KEEP OUT OF REACH OF CHILDREN

May cause eye and skin irritation. In case of contact, immediately flush eyes or skin with plenty of water and continue flushing for 15 minutes. If irritation persists, seek medical attention. If this product has been swallowed and the person is conscious, immediately give large volumes of water. Do not induce vomiting.
