

GENERAL INFORMATION

Spreader NF is a non foaming spreader-activator which gives guick wetting, absorption and aids in assimilation and translocation. Spreader NF can be used with insecticides, miticides, herbicides, defoliants and fungicides.

DIRECTIONS FOR USE

This product may be used in dilute or concentrate sprays. Rates Per 100 Gallons or Less of Spray Mix Per Acre for Acaracides, Insecticides and Fungicides: application; 1-4 pints; ground sprayers; 2-4 quarts: Herbicides and Defoliants: 1-4 pints, Add Spreader NF to spray tank first.

Note: The above use recommendations are considered to be adequate for most uses. Some pesticides, however, may require higher rates for optimum effect. Follow the pesticide label directions when this occurs. However, do not add this product at a rate which exceeds 5% of the total spray volume.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Keep in original container. Store in cool, dry place. from children. Do not reuse empty container. Triple rinse during mixing and loading and add rinse water to spray tank. Offer decontaminated containers for recycling or reconditioning, or puncture and dispose of in sanitary landfill.
