DIRECTIONS FOR USE

This product may be used in dilute or concentrate sprays. Rates Per 100 Gallons or Less of Spray Mix Per Acre for Acaracides, Insecticides and Fungicides: Aerial application; 1-2 pints; ground sprayers; 1-2 guarts: Herbicides and Defoliants: 1-4 pints. Add INTAKE to spray tank first.

Note: The above use recommendations are considered to be adequate for most uses. Some pesticides, however, may require higher rates for IF SWALLOWED:-Call a poison control center or doctor optimum effect. Follow the pesticide label directions when this occurs.
