A jar test for compatibility is suggested before mixing to apply to a commercial field.		
<b>When to Apply:</b> Apply as a foliar spray, targeting adult growth stage. Reapply as necessary but no closer than a 14-day interval.		
<b>Restrictions:</b> Do not apply within <b>3 days</b> of harvest. Maximum product allowed per 14-day interval: <b>3.2 fl oz/A (or 0.05 lbs ai/A)</b> . Maximum product allowed per crop season: <b>12.8 fl oz/A (or 0.2 lbs ai/A)</b> . Minimum application volume (water): 50 GPA – ground; 25 GPA – aerial application.
