#### **Resistance Management:**

- Make no more than 2 sequential applications before rotating to a fungicide with a different mode of action.
- Do not follow soil applications of Orondis with foliar applications of Orondis Opti A. Use either soil
  applications or foliar applications but not both for disease control.
- When less than 3 applications are made in a total spray program, one or both sprays may be Orondis Opti A.

#### **USE RESTRICTIONS**

- 1) Maximum Single Application Rate: Do not exceed 4.8 fl oz per acre per application.
- 2) Maximum Annual Rate: Do not exceed 19.2 fl oz per acre per year.
- 3) Maximum Number of Applications:
  - a. Do not exceed six foliar applications per acre per year for the same crop.
  - b. Do not use for more than 33% of the total foliar fungicide applications.
- 4) Minimum Application Interval: 3 days
- 5) Pre-harvest Interval (PHI): 0 days
