### DIRECTIONS FOR USE

#### CONTAINER GROWN NURSERY CROPS:

Apply 3.5 lbs. of Soaker™ Max G per cubic yard of soil.

GOLF COURSES (Greens, Tees, and Fairways) and ATHLETIC FIELDS For maintenance: Apply 2.5 lbs. of SOAKER MAX® G per 1,000 sq. ft. Apply monthly, starting one month before anticipating stress conditions. Irrigate before next mowing, or leave baskets off to ensure that SOAKER MAX® G makes contact with

#### LAWNS - GENERAL TURF

For curing stress problems: Apply 3.75 lbs. of SOAKER MAX® G per 1,000 sq. ft. Re-apply 2 weeks later at same rate if necessary.

For Maintenance: Apply 2.5 lbs. SOAKER MAX® G per 1,000 sq. ft. Re-apply monthly as needed.

#### SEEDING

SOAKER MAX® G may enhance the uniform germination of turf seed by improving drainage and water availability in treated soils. Apply SOAKER MAX® G at 2.5 lbs. per 1,000 sq. ft. 2 weeks prior to seeding.

#### SODDING

Apply 2.5 lbs. of SOAKER MAX® G per 1,000 sq. ft. after laying the sod. GARDEN & LANDSCAPE

Trees and Shrubs: Apply SOAKER MAX® G at 3.75 lbs./1,000 sq. ft., uniformly from drip line to trunk. Repeat on a monthly basis or as needed.

#### **INSTALLATION:**

Trees and Shrubs: Spread 0.5 lbs. of SOAKER MAX® G into hole and then apply 0.75 lbs. over the surface for each foot of rootball diameter. Or, thoroughly mix 3.75 lbs./cubic yard of backfill. Then continue applications according to instructions noted in the GARDEN & LANDSCAPE section of label.

Sodding and/ or Seeding: Spread SOAKER MAX® G at 2.5 lbs./1,000 sq. ft. or 110 lbs /acre after laying sod or applying grass seed
