Wheat Stem Maggot (adult)	1.8 – 2.4	0.014 – 0.019	Apply as a foliar spray at or just prior to peak adult emergence, typically around the 4-5 leaf growth stage. Reapply as necessary but no closer than a 3-day interval. May be applied with postemergence grass, broadleaf herbicides and/ or fungicides.

Notes and Restrictions:

Pre-Grazing or Foraging Interval: **3 days**. Pre-Harvest Interval (PHI): **30 days**.
Maximum BAYTHROID XL allowed per 3-day interval: **2.4 fluid ounces/Acre (0.019 lb AI/Acre)**.
Maximum BAYTHROID XL allowed per crop season: **4.8 fluid ounces/Acre (0.038 lb AI/Acre)**.
