DIRECTIONS FOR USE

Precaution: Phyte-Off PLUS is a highly concentrated material. Exercise precautions to prevent potential root or foliar burning, or soil media pH changes. If applying Phyte-Off PLUS in combination with other materials, a compatibility test is recommended to avoid potential incompatibilities. Prior to the addition of Phyte-Off PLUS to a spray mix, the user or application advisor must have experience with the combination or should have conducted a phytotoxicity trial. Do not mix with fixed copper or copper-based fungicides if the pH of the spray solution is below pH 6. Use sufficient water to ensure thorough coverage.
