- 4. Continue to agitate until tank is 3/4 full

Ground Application: Use 0.5 - 1% volume to volume of SOY OIL SPRAY CONCENTRATE in enough water to insure good plant coverage with equipment being used. (2-4 quarts per 100 gallon).
