#### NOT FOR AQUATIC USE.

COMP-AD ES is completely soluble in most liquid fertilizers and should be added to the fertilizer at the above suggested rates and mixed thoroughly prior to the addition of the pesticide. The entire mixture should be agitated sufficiently to provide a uniform suspension and agitation should be continued during application if possible.
