GENERAL INFORMATION

PRO-CAL ANF is designed primarily for foliar applications to prevent or correct micronutrient deficiencies in a wide range of turf and ornamental plants. Its use is suggested as a supplement to a regular, balanced fertilizer program to enhance yields and improve quality.

Application of PRO-CAL ANF is a means of obtaining a quick response to needed elements. Foliar applications of PRO-CAL ANF may be particularly beneficial during periods of peak nutrient demand, for crops grown on soils having poor nutrient availability or to crops suffering from a weakened root system. PRO-CAL ANF should be used as part of a comprehensive Total Nutrition System[™] for optimizing plant growth, development, yield and quality.

DIRECTIONS FOR USE

PRO-CAL ANF may be applied as a foliar spray by air, ground concentrate or dilute. Maintain agitation to provide uniform distribution within spray tank. Use of a high quality CPDA approved spreader, such as R-11®, at recommended rates to improve spray cover is usually advised. Do not apply when plants are under excessive heat or moisture stress. Applications of foliar nutrients to leafy vegetables or soft-skinned fruits during periods of excessive temperatures may cause cosmetic injury. Applications of certain micronutrients to fleshy fruits within 30 days of harvest may result in staining of rind or skin.

Add PRO-CAL ANF to tank when half full; agitate thoroughly while adding remaining water. Water temperature plays an important role in determining fertilizer solubility. The higher the water temperature, the greater the solubility and quicker the dissolving time. As fertilizers are added to the solution, there is an immediate decrease in water temperature. It is important when preparing concentrated solutions to allow for this temperature drop to ensure that all of the fertilizer is properly dissolved.

SPRAY TANK: Mix 1/2 pound in 25 gallons water and apply 1 quart per square foot as a normal watering on a 1 to 2-week basis.

TRANSPLANTS (Vegetables, Flowers, Trees, Shrubs, Seedlings, etc.): Mix 1 pound in 50 gallons of water and apply on a 2 to 3-week basis. Water in thoroughly.

FOLIAR FEED: Mix 1 pound in 50 gallons (350 ppm N) and use every 2 to 3 weeks. Do not spray flowers in bloom.

ESTABLISHED LAWNS, GOLF COURSES AND TURF AREAS: Use 5 pounds in 100 gallons of water per 5,000 sq. ft., or 1 pound in 10 gallons of water per 1,000 sq. ft., or 15 level tablespoons in 4 gallons of water per 400 sq. ft. Repeat applications every week to two weeks or as turf shows need. This product MAY be applied in a concentrated solution of 1 pound in 2 to 3 gallons of water, provided it is well soaked into the soil immediately after application or when soil moisture is very high.

SHADE TREES AND SHRUBS: Use at the rate of 5 to 10 pounds per 100 gallons of water. Apply early in the growing season and whenever supplemental feeding is necessary to improve plant vigor and appearance.

LOW VOLUME APPLICATION (Backpack Sprayers): 1 teaspoon per gallon of water.

NOTE: It is recommended that the final spray solution be a pH of 6.5-7.0. If buffering is required, Wilbur-Ellis recommends a buffering agent such as TRI-FOL®. No surfactant should be used with this product unless advised by your Wilbur-Ellis consultant.
