## **HAZARD STATEMENTS:**

**Synonyms:** Myclobutanil:  $\alpha$ -butyl- $\alpha$ -(4-chlorophenyl)-1H-1,2,4-triazole-1-propanenitrile Ingredients not precisely identified are proprietary or non-hazardous. Values are not product specifications.

## 4. FIRST AID MEASURES

**If Swallowed:** Call a poison control center or doctor immediately for treatment advice. Do not give any liquid to the person. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

**If in Eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**If on Skin or Clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.

**If Inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

**Most Important symptoms/effects, acute and delayed**: Eye exposure may cause mild irritation. **Indication of Immediate medical attention and special treatment if needed, if necessary**: None expected.

#### 5. FIRE FIGHTING MEASURES

**Extinguishing Media:** Use extinguishing media suitable for surrounding materials. Dry chemical, carbon dioxide, foam, water spray or fog.

**Special Fire Fighting Procedures:** Firefighters should wear NIOSH/MSHA approved self-contained breathing apparatus and full fire-fighting turn out gear. Dike area to prevent runoff and contamination of water sources. Dispose of fire control water later.

**Unusual Fire and Explosion Hazards:** If water is used to fight fire, contain runoff, using dikes to prevent contamination of water supplies. Dispose of fire control water later.

Hazardous Decomposition Materials (Under Fire Conditions): May produce gases such as oxides of carbon and nitrogen.

## 6. ACCIDENTAL RELEASE MEASURES

**Personal Precautions:** Wear appropriate protective gear for the situation. See Personal Protection information in Section 8.

**Environmental Precautions:** Prevent material from entering public sewer systems or any waterways. Do not flush to drain. Large spills to soil or similar surfaces may necessitate removal of topsoil. The affected area should be removed and placed in an appropriate container for disposal.

**Methods for Containment:** Dike spill using absorbent or impervious materials such as earth, sand or clay. Collect and contain contaminated absorbent and dike material for disposal.

**Methods for Cleanup and Disposal:** Avoid creation of dusty conditions. Scrape up and place in appropriate closed container. Wash entire spill area with a detergent slurry, absorb and sweep into container for disposal. Decontaminate tools and equipment following cleanup. See Section 13: DISPOSAL CONSIDERATIONS for more information.

**Other Information:** Large spills may be reportable to the National Response Center (800-424-8802) and to state and/or local agencies.

## 7. HANDLING AND STORAGE

**HANDLING**: Do not get in eyes or on clothing or skin. Users should wash hands and exposed skin before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing/Personal Protective Equipment (PPE) immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove Personal Protective Equipment (PPE) immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

**STORAGE:** Store in a cool, dry secure area at temperatures above freezing and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food and feed. Store in original container and out the reach of children. Do not contaminate water, food, or feed by storage or disposal.

## 8. EXPOSURE CONTROLS / PERSONAL PROTECTION

# **Engineering Controls:**

Where engineering controls are indicated by specific use conditions or a potential for excessive exposure, use local exhaust ventilation at the point of generation.

**Eye/Face Protection:** Not normally required. To avoid contact with eyes, wear chemical goggles or shielded safety glasses. An emergency eyewash or water supply should be readily accessible to the work area.

**Skin Protection:** To avoid contact with skin, wear long pants, long-sleeved shirt, socks and shoes. An emergency shower or water supply should be readily accessible to the work area.

**Respiratory Protection:** Not normally required. If vapors or mists exceed acceptable levels, wear NIOSH approved air-purifying respirator with cartridges/canisters approved for use against pesticides.

## 10. STABILITY AND REACTIVITY

Reactivity: Not reactive

Chemical Stability: This material is stable under normal handling and storage conditions.

## 11. TOXICOLOGICAL INFORMATION

Likely Routes of Exposure: Eye contact, Skin contact

**Symptoms of Exposure:** 

Eye Contact: Minimally irritating based on toxicity studies.

Skin Contact: Minimally toxic and slightly irritating based on toxicity studies.

**Ingestion:** Moderately toxic based on toxicity studies.

Inhalation: Low inhalation toxicity. Inhalation of glycerin mists may cause irritation of respiratory tract.

Delayed, immediate and chronic effects of exposure: None reported.

## **Toxicological Data:**

Data from laboratory studies conducted are summarized below:

**Oral:** Rat LD<sub>50</sub>: >5.000

**Dermal:** Rat LD<sub>50</sub>: >5,050 mg/kg

Inhalation: Rat 4-hr LC<sub>50</sub>: >2.21 mg/L (no mortalities at highest dose tested)

**Eve Irritation:** Rabbit: Mildly irritating (MMTS=2.7) **Skin Irritation:** Rabbit: Slightly irritating (PDII= 0.3)

Skin Sensitization: Not a contact sensitizer in guinea pigs following repeated skin exposure.

Subchronic (Target Organ) Effects: Repeated overexposure to myclobutanil may cause effects to liver,

testes, adrenal gland, kidney and thyroid.

Carcinogenicity / Chronic Health Effects: Prolonged overexposure to myclobutanil may cause liver. kidney and reproductive system damage. Myclobutanil did not cause cancer in laboratory animals.

Reproductive Toxicity: In laboratory animals, effects on reproduction have been seen only at doses that produced significant toxicity to the parent animals.

Developmental Toxicity: Myclobutanil did not cause birth defects in laboratory animals. Has been toxic to the fetus in laboratory animals at doses non-toxic to the mother.

Genotoxicity: In-vitro, in vivo and animal genetic toxicity studies were negative for myclobutanil.

Assessment Carcinogenicity: None listed with ACGIH, IARC, NTP or OSHA.

## **Environmental Fate:**

Myclobutanil is degraded in the soil under aerobic conditions by microbial action. It is not degraded under anaerobic conditions. The field half-life in soil is approximately 66 days for sandy loam. In water, Myclobutanil is hydrolytically stable showing no hydrolysis after 28 days. In aqueous solutions, it decomposes on exposure to light with at half-life ranging from 15-25 days.

## 13. DISPOSAL CONSIDERATIONS

**Waste Disposal Method:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Improper disposal of excess pesticide is a violation of Federal law.

Container Handling and Disposal: For containers smaller than 5 gallons: Nonrefillable container: Do not reuse or refill this container.

**Triple rinse as follows:** Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by State and local authorities. Plastic containers are also disposable by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.

**Nonrefillable Containers Larger than 5 Gallons:** Nonrefillable container. Do not reuse or refill this container. Offer for recycling if available. Triple rinse or pressure rinse container (or equivalent) promptly after emptying.

**Triple rinse as follows:** Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

**Pressure rinse as follows:** Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

**Refillable container:** Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal, empty the remaining contents from this container into application equipment or a mix tank. Fill the container about 10% full with water. Agitate vigorously or recirculate water with the pump for two minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times.
