APPLICATION PROGRAMS: For application to areas affected by hydrophobic soil conditions and localized dry spot on all types of turf; golf greens, tees, fairways, sports fields and other turf areas. Repeat treatments according to the program of application selected.

Make the first application at the start of growing season, continuing applications throughout season, making last applications late in the growing period. A programmed regiment will reduce the damage of hydrophobic soils and prevent the reformation of localized dry spots.

WATERING IN PROCEDURES: It is not essential to water in the 6 oz rates of ALLEVIATE but to obtain the best effects from applications and to achieve the desired curative effects, water in as soon as possible or apply during rainfall.
