Sugar Power can be used on the following Field Crops: alfalfa, asparagus, bean crops, canola, clover, corn, cotton, cruciferous crops, cucurbits, melons, milo, onion/garlic, peanut, pepper, potato, rape (canola), rice, soybean, sugar beet, sugarcane, sunflower, tobacco, tomato, vegetable crops, wheat/barley/rye/oat; and on the following Fruit and Nut Crops: almond, apple, apricot, avocado, banana, berry crops, cherry, citrus, coffee, fig, filbert, grapes, hazelnut, oil palm, olive, persimmon, peach, pear, pecan, pistachio, plums/prunes, pomegranate, strawberry and walnut.
