Tree Nuts Crop Grouping including Vines: Almond, Beech nut, Betelnut Palm, Brazil nut, Butternut, Cashew, Chestnut, Chinquapin, Filbert, Grapes (all types), Hickory nut, Kiwi, Macadamia nut, Pecan, Pistachio and Walnut.

- It is a violation of Federal law to use this product inconsistent with its labeling.
- This recommendation must be in the possession of the user at the time of pesticide application.

Do not apply K-PHITE 7LP at intervals of less than three days.
		Aerial	1-3 quarts in a minimum of 10 gallons of water/acre	Apply at 2-3 week intervals. Do not apply K-PHITE 7LP at intervals less than 3 days.
		Irrigation	Overhead: 2-4 quarts in at least 100 gallons of water. Drip: 2-3 quarts in at least 100 gallons of water.	Apply at 2-3 week intervals on a treated acre basis, use lower rates on first and second leaf trees, use higher rates on third leaf and greater. Do not apply K-PHITE 7LP at intervals of less than three days.
