### 4. FIRST AID MEASURES

#### 4.1 Description of First Aid Measures

General Advice: Get medical attention if symptoms occur.

- Eye contact:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.
- Skin contact:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.
- Ingestion:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.
- Inhalation:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferable by mouth-to-mouth, if possible. Call a poison control center or doctor for treatment advice.

#### 4.2 Most Important Symptoms and Effects, Acute and Delayed

- Overview:** Exposure to solvent vapor concentrations from the component solvents in excess of the stated occupational exposure limits may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on the kidneys, liver and central nervous system. Symptoms include headache, nausea, dizziness, fatigue, muscular weakness, drowsiness and in extreme cases, loss of consciousness. Repeated or prolonged contact with the preparation may cause removal of natural fat from the skin resulting in dryness, irritation and possible non-allergic contact dermatitis. ### 5.3 SPECIAL PROTECTIVE EQUIPMENT AND PRECAUTIONS FOR FIREFIGHTERS

Special Protective Equipment for Firefighters: Self-contained breathing apparatus and full protective gear should be worn in fighting large fires involving chemicals. Use water spray to keep fire exposed containers cool. Keep people away. Isolate fire and deny unnecessary entry.

## 6. ACCIDENTAL RELEASE MEASURES

### 6.3 METHODS AND MATERIALS FOR CONTAINMENT AND CLEAN-UP

Contain and absorb spillage with non-combustible materials e.g. sand, earth, vermiculite. Place in closed containers outside buildings and dispose of according to the Waste Regulations.
