## FIRST AID

**CALL A POISON CONTROL CENTER OR DOCTOR IF YOU FEEL UNWELL.**

**If in eyes:** Hold eyes open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

**If swallowed:** Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

## GENERAL INFORMATION

PREMIUM CROP OIL CONCENTRATE is a highly refined crop oil concentrate that improves wetting and penetration of pesticides. It is designed for use where the pesticide label recommends the use of an oil concentrate adjuvant. PREMIUM CROP OIL CONCENTRATE also reduces the evaporation loss of spray droplets due to variations in temperature or humidity.

## DIRECTIONS FOR USE

Prior to use read all directions on this label and on the label of the product used. The product label for specific usages and restrictions have precedence over directions for uses referred to on this label.



## MIXING INSTRUCTIONS

**SHAKE WELL OR RECIRCULATE BEFORE USE**  
(Recirculate bulk if stored below 32°F)

1. Fill sprayer 1/3 to 1/2 full of water
2. Add dry flowables or dispersible granules
3. Add emulsifiable concentrates
4. Continue to agitate until tank is 3/4 full
5. Add PREMIUM CROP OIL CONCENTRATE last to the agitating spray tank

## RECOMMENDED RATES

**Ground:** 1 - 4 pints in 20 - 50 gallons of spray solution

**Air, CDA, Low Volume:** 4 - 8 pints per 100 gallons of spray (0.5% - 1.0% v/v concentration)

Do not use less than 0.5% by volume or more than 2.5% by volume.

## STORAGE AND DISPOSAL

**Storage:** Store in original container. Keep container tightly closed. Do not allow water or other chemicals to be introduced into contents of container. Do not contaminate water sources with equipment wash water, spray disposal waste or by cleaning of equipment. Keep away from food, feed or other product, especially oxidizing agents, to prevent contamination.

**Disposal:** Do not reuse product containers. Triple rinse (or equivalent), then offer for recycling at an ACRC site (go to <http://www.acrecycle.org/> for locations) or by reconditioning, or puncture and dispose of in a sanitary landfill or by other procedures approved by local, state, and federal regulations.
