## **Storage Instructions**



#### **Directions for Use**

Apply 1 pint of Root Power per acre through drip irrigation per week. Alternatively, apply 2 ounces per acre of Root Power through any other manner of irrigation or soil drench in the rooting area of the plants.

This application of 1 pint per acre per week should begin after plant is transplanted or at approximately the 2 to 3 leaf stage on plants which are started by planting seeds.

Stoller's Root Power may be diluted in any amount of water at the time of application. Application should continue until harvest is completed. At that time, the applications may be discontinued.
