Nutrients contained in **LINK Fe5** are readily available when applied to plant foliage or directly to the soil.

LINK Fe5 is designed primarily for foliar applications to prevent or correct iron deficiencies in turf and a wide range of ornamental plants. **LINK Fe5** should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development and quality. Application of **LINK Fe5**

is a means of obtaining a quick response to needed plant nutrients and beneficial elements.

Foliar applications of **LINK Fe5** may be particularly beneficial during periods of peak nutrient demand, for plants grown on soils having poor nutrient availability, for plants suffering from a weakened root system or for other plant stresses. **LINK** products are formulated specifically for the professional market including greenhouse, field and container-grown nursery, sports turf, golf, lawn care, and landscape managers.

DIRECTIONS FOR USE

When applying **LINK Fe5**, maintain agitation to provide uniform distribution within spray tank. If a spreader is desired or recommended in the mix, use a high quality CPDA approved spreader, such as **DENALI-EA™** or **RAINIER-EA™**, at recommended rates to improve spray coverage. Do not apply when plants are under excessive heat or moisture stress.

TURFGRASS

Greens and Tees: Apply 2-4 ounces per 1,000 sq. ft. with sufficient water to prevent tip burn (1-2 gallons). Repeat as needed. Corresponding rates per acre are 2.75-5.5 quarts in 40-80 gallons of water.

Fairways and Lawns: Apply 4-6 ounces per 1,000 sq. ft. with sufficient water to prevent tip burn (1-4 gallons). Repeat as needed. Corresponding rates per acre are 5.5-8.25 quarts in 40-160 gallons of water.

LANDSCAPE ORNAMENTALS

FOLIAR SPRAY APPLICATIONS:

Herbaceous Plants: Apply 1-2 pints per 100 gallons of water. Spray to runoff. Repeat as necessary.

Trees and Shrubs: Apply 2-4 quarts per 100 gallons of water. Spray to runoff. Repeat as necessary.

SOIL DRENCH APPLICATIONS: Mix 3-6 ounces per gallon of water and thoroughly drench soil area.

Established Palms: Apply 1-2 quarts per 100 gallons and spray to runoff.

NURSERY AND GREENHOUSE

FOLIAR SPRAY APPLICATIONS: Apply 1 quart per 100 gallons of water. Spray to runoff. Repeat every 30 days or as needed.

INJECTION APPLICATIONS: Apply at a rate of 15-30 ppm of iron. For 15 ppm of iron, prepare a stock solution of 3.25 ounces per gallon of water and inject stock solution at a ratio of 1:100.

LINK Fe5 is compatible with most liquid plant protection products. Always jar test new combinations for compatibility prior to field mixing.
