VOYAGER 90/10 is an excellent quality, nonionic surfactant. *VOYAGER 90/10* can be used with most insecticides, fungicides, herbicides, acaricides, defoliants, desiccants and wettable powders to improve performance of the active spray ingredient by giving them more uniform distribution and better wetting of the plant surface. *VOYAGER 90/10* meets the requirements of most pesticide manufacturer's for a 90/10 surfactant.
