# **GENERAL INFORMATION**

FOLI-GRO® 15-10-5 is formulated primarily for foliar applications to prevent or correct micronutrient deficiencies in a wide range of agronomic and ornamental plants. Its use is suggested as a supplement to a regular, balanced fertilizer program to enhance yields and improve quality. Application of FOLI-GRO 15-10-5 is a means of obtaining a quick response to needed elements. Foliar applications of FOLI-GRO 15-10-5 may be particularly beneficial during periods of peak nutrient demand, for crops grown on soils raving poor nutrient availability or to crops suffering from a weakened root system. Avoid foliar nutrient applications to crops during periods of moisture, salinity or heat stress. Applications of foliar nutrients to sensitive crops such as leafy vegetables or soft-skinned fruit during periods of excessive temperatures may cause cosmetic injury. FOLI-GRO 15-10-5 should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development, yield and quality.

### DIRECTIONS FOR USE

FOLI-GRO 15-10-5 may be applied as a foliar spray by air or by ground. Maintain agitation to provide uniform distribution within the spray tank. Thorough and even spray coverage is essential for maximum nutrient uptake and crop safety. Always include a high quality wetting agent, such as R-11® or SYL-COAT®, at recommended rates. Optimum rate of application will vary based on a variety of factors including degree of need or deficiency, growth stage, yield potential, environmental conditions, existing soil fertility levels, soil pH, organic matter content, etc. For best results, follow soil test or plant analysis recommendations. For specific crop recommendations consult your local Wilbur-Ellis Company representative.

**FOLIAR APPLICATIONS (Ground or Air):** Apply the recommended amount of **FOLI-GRO 15-10-5** per acre per application throughout the growing season as needed to maintain adequate levels for growth. Severe deficiencies may require more frequent applications. Use sufficient water to ensure good coverage. Do not exceed 1 quart per gallon of water. If applied too concentrated, slight burning of the foliage may occur.

SOIL APPLICATIONS: Use 2 quarts to 5 gallons of FOLI-GRO 15-10-5 per acre as a preplant or side-dress application. Dilute with water for more uniform application. FOLI-GRO may be applied in combination with fertilizers. Always determine compatibility before preparing the application mix. Do not apply directly to the seed.

IRRIGATION SYSTEM APPLICATIONS (Soil, Drip or Sprinkler): FOLI-GRO 15-10-5 may be applied through irrigation systems at a rate of ½-1½ gallons per acre. Before applying with other fertilizers always check compatibility.

**BEANS, PEAS, PEPPERS AND TOMATOES:** Use 3 applications of 1-3 quarts per acre each application at 1-week intervals during bloom period.

**CABBAGE, CAULIFLOWER AND LETTUCE:** Use 2-4 applications as needed of 1-3 quarts each application. Final application should be made 1 week prior to cutting.

CANTALOUPES, CUCUMBERS, SQUASH AND WATERMELONS: Apply 2-3 quarts at intervals of 7-10 days as needed. First application should be made when runners form.

CITRUS: Add 2-4 quarts per 100 gallons of water or spray solution. Apply up to 3 times per year.

 $\textbf{CORN:} \ Apply \ 2 \ applications \ early \ season \ of \ 1-2 \ quarts \ each \ and \ 2 \ applications \ of \ 2-3 \ quarts \ each \ at \ silking \ and \ soft \ dough \ stage.$ 

**COTTON:** Apply 1-3 quarts per acre with regular insecticide program. Best results obtained with 3 applications at 1-week intervals during bloom period.

**GRAIN SORGHUM:** Use 1-2 applications of 2-4 quarts per acre each application prior to boot stage. **ORNAMENTALS:** Add 2 quarts per 100 gallons of water and thoroughly cover foliage. Repeat every 3-4 weeks or as needed.
