SECTION 2: HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW: Yellow liquid with slight solvent odor. May be fatal if swallowed. Causes eye and skin irritation. Combustible liquid.

Inhalation: Remove person from contaminated area to fresh air and assist breathing as needed. Seek medical attention

Ingestion: Seek medical attention or call a poison control center immediately for treatment advice. Do not induce

Eyes: Flush eyes with clean water for at least 15 minutes. Lift eyelids to facilitate irrigation. If present, remove

Note to Physician: Dimethoate is an acetyl cholinesterase inhibitor. Atropine is antidotal. 2-PAM may be effective as an adjunct to atropine. Contains petroleum distillate – vomiting may cause aspiration pneumonia.

SECTION 5: FIRE FIGHTING MEASURES

Suitable Extinguishing Media: Foam, carbon dioxide, dry chemical, or water spray.

Special Fire Fighting Procedures: Wear NIOSH/MSHA approved self-contained breathing apparatus and full bunker gear. Dike area to prevent runoff and contamination of water sources. Dispose of fire control water later. Avoid breathing vapors; keep upwind.

Hazardous Combustion Products: Oxides of nitrogen, sulfur, carbon and phosphorous

Unusual Fire and Explosion Hazards: Combustible liquid and vapor. Will ignite when exposed to heat, flame and other sources of ignition. Vapors can travel to a source of ignition and flash back causing and explosion and fire. Closed containers may rupture if exposed to excess heat or flame due to a build-up of internal pressure.

Methods for Clean-up: Cover contained spill with an inert absorbent material such as sand, vermiculite or other appropriate material. Do not use combustible materials such as sawdust.
