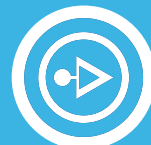

## FIRST AID

**If swallowed:** Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

## PRODUCT INFORMATION

**CONTRIVER** is a premium crop oil concentrate intended for use with products registered for agricultural, forestry, industrial, non-cropland, rights of way and other uses. **CONTRIVER** improves coverage and assists in penetrating the crop canopy and leaf cuticle.

## DIRECTIONS FOR USE

### Not for Aquatic Use

Read and follow all pesticide label directions.

Use caution when applying during hot, dry conditions.

If the user does not have experience with the mixture being applied, perform a jar test using the order and amounts in the mixture to determine compatibility and perform a phytotoxicity test to ensure crop safety.

Prior to mixing, fill the spray tank with half of the carrier. Start the sprayer and check to make sure that all valves and gauges work and that there is adequate tank agitation.

## MIXING INSTRUCTIONS

Add pesticides and/or fertilizers as directed by the label or in the following sequence:

- (1) Micronutrients and fertilizers,
- (2) Dry flowables and dispersible granules,
- (3) Flowables,
- (4) Water soluble pesticides,
- (5) Emulsifiable concentrates.

Continue agitation and add **CONTRIVER**. When completed, reduce agitation, and allow to mix for 1 to 2 minutes. While under minimal agitation, continue filling tank and allow to mix for 10-15 minutes prior to application.

## USE RATES

**Ground or Aerial:** 4 quarts per 100 gallons or 1.0% v/v.

Some pesticides have stated adjuvant use rates. In all cases, the pesticide manufacturer's label should be consulted regarding specific adjuvant use recommendations and that rate followed. Do not add this product at a level that would exceed 5% v/v of the finished spray solution volume unless otherwise specified by the pesticide label.

## STORAGE AND DISPOSAL

**Storage:** Store in a cool, dry place. Store in original container only. Do not store near fire, flame or other potential sources of ignition. Do not contaminate water, food or feed by storage or disposal of this product. **STORE ABOVE 32°F.**

**Disposal:** Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Dispose of contents/container according to all local, state, and national regulations. Recycling decontaminated containers is the best option of container disposal if allowed by law. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
