# GENERAL INFORMATION

LINK® HIGH MANGANESE MICRO MIX is a specially blended chelated liquid palm, tree, ornamental plant, and turf micronutrient product. It corrects manganese deficiencies as well as promotes the development of stronger root systems and more vigorous plants.

LINK HIGH MANGANESE MICRO MIX is designed primarily for foliar applications to prevent or correct magnesium, sulfur, iron, and manganese deficiencies in a wide range of agronomic and ornamental plants. Its use is suggested as a supplement to a regular, balanced fertilizer program to enhance yields and improve quality.

Application of LINK HIGH MANGANESE MICRO MIX is a means of obtaining a quick response to needed elements. Foliar applications of LINK HIGH MANGANESE MICRO MIX may be particularly beneficial during periods of peak nutrient demand, for crops grown on soils having poor nutrient availability or to crops suffering from a weakened root system.

LINK products are formulated specifically for the professional market including greenhouse. field and container grown nursery, sports turf, and landscape maintenance managers. LINK HIGH MANGANESE MICRO MIX should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development and quality.

## **DIRECTIONS FOR USE**

LINK HIGH MANGANESE MICRO MIX may be applied as a foliar spray by air, ground concentrate or dilute. Maintain agitation to provide uniform distribution within spray tank. Use of a high quality CPDA approved spreader, such as R-11®, at recommended rates to improve spray cover is usually advised. Do not apply when plants are under excessive heat

### **DIRECTIONS FOR USE (cont.)**

FOLIAR: Apply 2-6 ounces per gallon of water. Spray to runoff.

DRENCH: Apply 4-5 ounces per gallon of water. Use 2-3 gallons of mix on a sizable mature plant every 2-4 weeks until the deficiency is corrected.

TURF: Apply 2-6 ounces per 1,000 sq. ft. in a minimum of 1 gallon of water.

APPLICATION PRECAUTIONS: Iron and other plant nutrients can cause staining of sidewalks. Sweep walkways prior to irrigation. Walkways should be dry at time of application. Keep away from pools, ponds, etc. Do not contaminate potable water.

#### COMPATIBILITY

LINK HIGH MANGANESE MICRO MIX is compatible with most fertilizers and pesticides. It is non-phytotoxic when used as directed. Always check the compatibility of untested mixes. Always jar test new combinations for compatibility prior to field mixing.
