General Information

Hydro-Wet TG, when used in a water management program, will distribute water more uniformly throughout the root zone; eliminate localized dry spot; enhance turf quality, and reduce watering frequency.

Use Hydro-Wet TG to improve water efficiency on golf course fairways, greens or tees, athletic fields, residential and commercial lawns or any plant media or soil mix.

The dry granular carrier for Hydro-Wet TG is Terra-Green®. This inert, porous mineral is incorporated with liquid Hydro-Wet.

Hydro-Wet TG won't float off target and readily disperses into thatch area for release into soil profile. Hydro-Wet TG is an affective soil conditioner.

Storage and Disposal

Storage: Do not contaminate water, food or feed by storage or disposal of this product. Keep product cool and dry in sealed original bags.

Disposal: Do not reuse empty bags. Dispose of bags in accordance with all applicable federal, state and local regulations. If spill occurs, do not attempt to clean up with water, as area will become slippery. Simply sweep and dispose of material.

Directions For Use

Golf Course Greens: For use as a season-long preventive treatment: Apply Hydro-Wet TG at a rate of 2.0 to 2.5 pounds per 1,000 sq. ft. in early season. To maintain initial early season treatment, apply Hydro-Wet TG at a rate of 1.25 pounds every 2 to 4 weeks as needed. Irrigate treated areas lightly following application to move Hydro-Wet TG from the granule carrier and into the root zone. Hydro-Wet TG should be applied to dry turf.

Golf Course Fairways and Athletic Fields: Apply Hydro-Wet TG in advance of high heat and stress conditions at a rate of 100 pounds to the acre. Reapply at least two separate applications of 50 pounds per acre at two to three week intervals. Your results may vary based on equipment, operating speed and weather or climate conditions. Irrigate treated areas for 10 to 15 minutes immediately following application. DO NOT APPLY HYDRO-WET TG TO WET TURF.

Lawn Care: Apply Hydro-Wet TG at a rate of 2.5 pounds per 1,000 sq. ft. Repeat monthly as conditions require.

Newly Planted Nursery Material and Soil Media: Thoroughly mix 2.5 pounds of Hydro-Wet TG per cubic yard or backfill.
