Rate Recommendations

FOLIAR APPLICATION

Field, Row, Vegetable and Vine Crops: Apply 1/2-1 pint per acre per application throughout the growing season. More frequent applications at 1 pint per acre may be needed to correct deficiencies once they occur.

Fruit and Nut Tree Crops: Apply 1-4 pints per acre per application throughout the growing season. More frequent applications at 2 pint per acre may be needed to correct deficiencies once they occur.

Ornamentals: Apply 1-2 pints per 100 gallons water. Cover foliage thoroughly to point of runoff.

SOIL APPLICATION

All crops: Use 1-3 quarts in a minimum of 10 gallons of water per acre.

Mixing and Handling Instructions

Put 1/3 to 2/3 of total required water volume in tank. Add adjuvants, fertilizers, and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of this product and agitate until thoroughly mixed. Fill tank with remainder of desired water.

The use of an adjuvant is recommended. Performing trials with adjuvants may be useful in determining the best inclusion rates for optimal performance. Check chemical mixture compatibility using a jar test prior to application.

BRANDT SMART B is recommended for all crops where boron may be deficient; however overapplication may result in serious injury to susceptible crops.
