MACADEMIA NUTS	24-46.2 ounces	<p>HARVEST AID: Apply a foliar spray of ETHEPHON 2SL plant growth regulator to Macadamia trees a minimum of 5 -12 days prior to harvest. Mix 24 – 46.2 ounces of ETHEPHON 2SL in 100 gallons of water (450 to 863 ppm). Apply by ground at 100 to 200 gallons per acre depending on spray equipment and tree size.</p> <p>For best results, a thorough uniform spray coverage of leaves and nuts is needed. Some premature leaf drop will be associated with treatment. Do not apply to diseased, low vigor or moisture stressed trees as leaf drop may be excessive.</p>

## RESTRICTIONS/PRECAUTIONS

### RESTRICTIONS/PRECAUTIONS

- Do not apply more than 1.44 lbs. ethephon active ingredient per acre per year.
- Do not enter or allow worker entry during the restricted-entry interval (REI) of 48 hours.
- The REI is 72 hours in areas where average rainfall is less than 25 inches per year.
- Do not make more than 1 application per crop per year.
- Do not harvest until at least 5 days after application.
- Do not graze or feed cover crops grown in treated orchards.
- Mix only the amount of spray expected to be used on the day of application.
- Avoid spray drift to nearby crops to avoid temporary effects of the plant growth regulator.
- Use the lower rate during periods of low rainfall.
- Do not apply ETHEPHON 2SL through any type of irrigation system.
- Do not use this product for purposes other than those listed on the label.
