# RTU FORMULATION

## DIRECTIONS:

- **Shake container well with each use.**
- If sprayer clogs, rinse with hot water.
- **APPLY ON DRY PLANTS—Rainfast in 24 hours**
- **Deer/Elk/Moose**—spray mainly top of plant until wet, but not dripping.
- **Rabbits / Voles**—spray stem, lower leaves and surrounding area.
- **BULBS**—Dip in solution or spray liberally. Allow to dry. Then plant.
- **ORNAMENTALS**—spray mainly leaves of plants until wet—avoid blossoms.
- **Always treat new growth.**
- Test sample plants to determine sensitivity.
- Foliage may darken temporarily after treatment—original color returns in 1 or 2 days.
- Apply at above-freezing temperatures.
- For best results, apply in early morning or late afternoon.
- Avoid application in direct hot sunlight. (photodegradable).
- Treating Pine seedlings during bud flush is not recommended (OK before/after bud flush).

## CAUTION KEEP OUT OF REACH OF CHILDREN & PETS

- **DO NOT** ingest solution—wash hands after use.
- Do not apply directly onto edible parts of fruit, vegetables and other food crops within 30 days of harvest. **Wash fruit and vegetables before eating.**
- If solution comes into contact with eyes or skin, wash/flush with water.
- **Avoid spraying concrete and wood to prevent discoloration.**
- Rinse sprayer, gloves after use.
- Store in a cool, dark place for up to 90 days after opening.
- **DISPOSAL:** Rinse empty container thoroughly—**Recycle** or dispose with household garbage.
