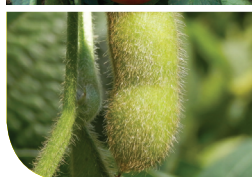

APPLICATION FOR ROW CROPS AND PRODUCE

- For best results, apply in-furrow with seed at a rate of 16-32 oz. per acre.
- Tank-mix flexible with most agricultural products, and can be foliar applied with chemicals and/or fertilizers.
- Bio-Strain can also be used as a pre-plant incorporated or pre-emergence soil spray at the rate of 32oz. per acre.
- Foliar application rates are recommended at 16-32oz. per acre (10-20 gal. of water).
- Can be applied through irrigation systems. Contact your Monty's representative for more information.

STORAGE AND HANDLING. Keep container closed when not in use. Do not store in direct sunlight. Do not exceed 100°. Do not allow to freeze. This product contains organic materials which may settle and should be agitated before application if stored or allowed to freeze. Refer to the MSDS for other safety and handling information.

USE OF MONTY'S PLANT FOODS WITH FARM CHEMICALS. Monty's products are compatible with many farm chemicals and may improve the efficacy of some, but Monty's does not guarantee it to do so.
