### GENERAL INFORMATION

**RNA MICROSOL B** is a water soluble and fertilizer soluble source of boron. It may be mixed and applied with fertilizers or pesticides on soil or foliage.

### DIRECTIONS FOR USE

**PRECAUTIONS:** The use of **RNA MICROSOL B** on any crops other than those recommended by a crop production specialist may result in serious injury to the crops. Always add PVA (water soluble bags) materials and thoroughly dissolve before adding **RNA MICROSOL B** to the mixture. When used with new materials or mixes, test spray a small area and check for fruit or plant injury before any large-scale spraying.

**FOLIAR APPLICATIONS:** Use sufficient water for thorough coverage. **RNA MICROSOL B** may be mixed with most pesticides. Check jar compatibility and treat a small area for damage before large-scale application begins. This product has a pH of approximately 5.0 with slight acidifying capacity. **RNA MICROSOL B** will decrease the pH of a spray solution approximately 0.5 units at a rate of 5 pounds per 100 gallons of water. Multiple applications are preferred over a single application. **SOIL APPLICATIONS:** **RNA MICROSOL B** may be applied to the soil with fertilizers or crop protection materials. **RNA MICROSOL B** may be mixed with dry fertilizers and certain liquid fertilizers.

**TREES AND VINES (Post-Harvest and Dormant):** Apply no more than 8 pounds per acre with sufficient water for thorough coverage. Apply prior to bloom, either in the fall, dormant or delayed-dormant. **Foliar:** Apply up to 5 pounds per acre with sufficient water for thorough coverage. The number of applications is dependent upon the deficiency. **Soil:** Apply 3-10 pounds per acre. Rate depends upon the deficiency. Apply with irrigation water, fertilizer, or pesticides.

**ROW, FIELD AND OTHER CROPS:** **Foliar:** Apply up to 3 pounds per acre with sufficient water for thorough coverage. The number of applications is dependent upon the deficiency. The maximum solubility is 3 pounds per 10 gallons of water. **Soil:** Apply 3-10 pounds per acre; rate depends upon the deficiency. Apply with irrigation water, fertilizer, or pesticide.

**RNA MICROSOL B** is compatible with metal sulfates, such as zinc sulfate solution. Always jar test new combinations for compatibility prior to field mixing.
