

BIOXst is a premium zinc based seed treatment, utilizing zinc EDTA and an amino acid complex providing early plant nutrition, development, germination and uptake. BIOXst is recommended as an additional zinc application method and is not intended to replace other zinc products. **BIOXst** is a highly efficient readily available chelated zinc to help support crop growth in cold soils where zinc uptake can be limited.

RECOMMENDED APPLICATION RATE:

BIOXst is for use as a pre-plant commercial seed treatment. It can be used on but is not limited to the following Seeds listed in the table below. General use rates range from 2 – 10 oz / cwt for most crops.

RECOMMENDED RATES FOR SPECIFIC CROPS

Crop oz/cwt (100 lb seed) Soybeans 1 - 2 oz. Corn 2 - 3 oz Wheat 1 - 2 oz

Use only in case of a recognized need. Do not exceed recommended dose. Do not apply undiluted. Due to the biological nature of this product, separation and color variations are normal.

SHAKE WELL BEFORE USE

This product is stable at ordinary temperatures and pressures. Store in a dry place at temperatures between 40° and 95° F. Keep out of reach of children and animals. Avoid contact with eyes and skin. In case of accidental spillage of fertilizer, collect with absorbent material.
