toxicity or teratogenicity. Tremors were associated with repeated exposure of laboratory animals with Bifenthrin. In lifetime feeding studies conducted with rodents, a slight increase in the incidence of urinary bladder tumors at the highest dose in male mice was considered to be an equivocal response, not evidence of a clear compound-related effect. The overall absence of genotoxicity has been demonstrated in mutagenicity tests with bifenthrin.
