SEED LABELING: Treated seed must be labeled "Do not use this treated seed to grow coriander or cilantro for human or animal consumption in the United States. For export only and for use on seed planted to produce coriander grown for seed." The U.S. Seed Act requires that treated seed be labeled with the following information:

This seed treated with Thiram at the rate recommended by the manufacturer. Treated seed must not be used for, or mixed with food or animal feed or processed for oil. Exposed treated seed may be hazardous to birds and other wildlife. Dispose of all excess treated seed and seed packaging by burial away from bodies of water.
