FIRST AID

CALL A POISON CONTROL CENTER OR DOCTOR IF YOU FEEL UNWELL

If in eyes: Hold eyes open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes then continue rinsing eyes. Call a poison control center or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

If swallowed: Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by a poison control center or doctor. Have person sip a glass of water if able to swallow. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

GENERAL INFORMATION

CHEM-N is a 28% liquid ammonium nitrate-urea solution designed to increase herbicide performance through increased absorption into the plant's phloem through the leaf cuticle.

DIRECTIONS FOR USE

Prior to use read all directions on this label and on the label of the product used. The product label for specific usages and restrictions have precedence over directions for uses referred to on this label.

MIXING INSTRUCTIONS

SHAKE WELL OR RECIRCULATE BEFORE USE.

1. Fill sprayer 1/3 to 1/2 full of water
2. Add CHEM-N to the agitating spray tank
3. Add dry flowables or dispersible granules
4. Add emulsifiable concentrates
5. Continue to agitate until tank is full

RECOMMENDED RATES

Use Rates: For specific tank mix recommendations using CHEM-N 28-0-0, refer to the manufacturer's label.

STORAGE AND DISPOSAL

Storage: Do not store using brass, bronze, copper, zinc or alloys of these, contact with UAN solution causes corrosion; cast iron, malleable iron or ductile iron are much more susceptible to corrosion than aluminum or carbon steel. Pay extra close attention to plugs and fittings on storage tanks. If stored below freezing, thoroughly thaw and agitate before use, store above 0°F. Keep containers tightly closed. Store in original container. Do not allow water or other chemicals to be introduced into contents of container. Do not contaminate water sources with equipment wash water, spray disposal wastes or by cleaning of equipment. Do not store near feed or food products. Do not use or store near open flame.

Disposal: Do not reuse product containers. Triple rinse (or equivalent), then offer for recycling at an ACRC site (go to <http://www.acrecycle.org/> for locations) or by reconditioning, or puncture and dispose of in a sanitary landfill or by other procedures approved by local, state, and federal regulations.
