#### 5. Fire-fighting measures

#### 6. Accidental release measures

If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. Collect dust using a vacuum cleaner equipped with HEPA filter. Following product recovery, flush area with water. Sweep up or vacuum up spillage and collect in suitable container for disposal. Minimize dust generation and accumulation. Prevent entry into waterways, sewer, basements or confined areas. For waste disposal, see section 13 of the SDS.
<b>Environmental precautions</b>	Avoid release to the environment. Inform appropriate managerial or supervisory personnel of all environmental releases.
