DESCRIPTION

RotoRip flocculates/adds structure to the applied soil. It can be used as a water penetrant, soil surfactant, and soil remediation agent for salt and sodium reduction, uniform water distribution, and better wetting of the soil profile. RotoRip will reduce water runoff resulting in more uniform soil profile wetting, increased soil moisture content and facilitate removal of salts and sodium when followed by excess water applications to achieve soil leaching. RotoRip has also shown to increase capillary water holding capacity in lighter soils. RotoRip may be applied in season to growing crops.

Designed for: Irrigation systems excluding earthen ditches, or Sprayer applications followed by irrigation to incorporate.

RATES use 1-8 Quarts/Acre/Application

Rates will vary due to: Sodium content of soil Salinity content of soil, crop tolerance to salinity, and Irrigation type
