GENERAL INFORMATION

SmartLine™ AMS MAXX™ contains water conditioning properties and a homogenized deposition agent designed to improve the precision of spray applications and reduce off-target drift. It is suitable for use on both conventional and transgenic crop varieties.

When used at labeled rates, SmartLine AMS MAXX will optimize the angle of the spray pattern, as the spray exits the nozzle, to give maximum coverage of target surfaces while minimizing "pattern fringe" which contains the most driftable particles.

SmartLine AMS MAXX is intended for use as a tank-mix adjuvant where a deposition or drift control agent is required or recommended. SmartLine AMS MAXX will NOT eliminate all drift

SmartLine AMS MAXX technology has been proven to increase glyphosate activity. This product also contains emollients which may improve absorption of herbicides into leaf surfaces.

SmartLine AMS MAXX also contains buffering and sequestering agents to adjust pH to a neutral range.

SmartLine AMS MAXX may be used when the pesticide label recommends the use of a deposition aid or drift control agent. It is not intended as substitute for surfactants or crop oil concentrates.

DIRECTIONS FOR USE

SmartLine AMS MAXX is intended for use with products registered for agricultural, horticultural, turf, ornamental, industrial, and non-crop use. SmartLine AMS MAXX should be added to the diluted spray solution prior to the addition of any pesticides.

Use Rates

Typical application: Use 2 to 4 quarts per 100 gallons

For enhanced water conditioning, drift suppression, and applications using spray pressures of 50 psi or greater: Use up to 6 quarts per 100 gallons

NOTE: Do not exceed maximum use rate. Always monitor spray pattern to avoid reduced coverage when using higher rates.

SmartLine AMS MAXX contains the equivalent of 2 pounds ammonium sulfate per gallon.

SMARTLINE AMS MAXX IS NOT FOR AQUATIC USE

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Storage: Store at ambient temperature. Store in a closed container. Keep this container tightly closed. Store in original container. Do not allow water or other chemicals to be introduced into contents of container. Do not contaminate water sources with equipment washwater, spray disposal wastes or by cleaning of equipment. Do not store near feed or food products. Do not use or store near open flame.

Disposal: Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. Decontaminated containers may also be disposed of in a sanitary landfill. Dispose of contents/container in accordance with local/national regulations.

FIRST AID
