Special Instructions continued

Preemergent Weed Control

- To ensure thorough coverage, apply 10 to 30 gallons of spray solution per broadcast acre.
- Moisture is required to activate *Payload* Herbicide for residual weed control.
- A lack of rainfall after application may decrease efficacy.

Postemergent Weed Control

- To ensure thorough coverage, apply 20 to 30 gallons of spray solution per broadcast acre.
- If weeds have germinated at time of application, tank mix *Payload* Herbicide with an approved adjuvant.
- To improve postemergent control, *Payload* Herbicide may be tank mixed with glyphosate or other postemergent herbicides labeled for listed use sites.

Use Restrictions and Precautions

- Do not apply more than 12 oz. (0.375 lb. a.i./A) of *Payload* Herbicide per acre per year.
- Do not apply by air.
- Do not make a sequential application of *Payload* Herbicide within 30 days of first application.
- Do not use water from treated canal/ditch until 60 days has lapsed after last application of *Payload* Herbicide.
