## **General Information**

SmartLine<sup>™</sup> AMS Premium Blend<sup>™</sup> is a water soluble blend of ammonium sulfate, nonionic surfactant, deposition aid and antifoam agent.

SmartLine AMS Premium Blend is formulated to improve the efficacy of glyphosate-based pesticides and other post emergence pesticides that recommend ammonium sulfate or nitrogen solution and nonionic surfactant.

SmartLine AMS Premium Blend contains nonionic surfactant, to help increase the biological efficacy of pesticides.

Ammonium sulfate helps to reduce tank mix antagonism.

The antifoam agent in SmartLine AMS Premium Blend reduces the formation of troublesome foam. SmartLine AMS Premium Blend is micronized to aid in solubility and speed of tank mixing.

#### **DIRECTIONS FOR USE**

Always read and follow all label directions, mixing instructions, and precautionary statements of the pesticide being applied.

SmartLine $^{\text{TM}}$  AMS Premium Blend $^{\text{TM}}$  may be used with applications labeled for agricultural, industrial, non-cropland, and other uses when the pesticide label suggests, recommends, or requires the use of ammonium sulfate as an adjuvant to improve pesticide performance.

## **DETERMINING USE RATES**

The SmartLine AMS Premium Blend use rate must be determined by the pesticide label adjuvant recommendations and guidelines.

#### When the pesticide label recommends AMS rate per 100 gallons:

Substitute SmartLine AMS Premium Blend at the exact rate. For example; when 17 pounds per 100 gallons or 2% by weight is suggested, use 17 pounds of SmartLine AMS Premium Blend per 100 gallons of spray solution.

### When the pesticide label recommends AMS rate per acre:

Ammonium Sulfate Rate: When pesticide labels suggest a particular rate of AMS per acre, substitute the exact rate per acre using SmartLine AMS Premium Blend.

#### Mix these amounts of SmartLine AMS Premium Blend per 100 gallons:

## PREPARING SPRAY SOLUTION

Thoroughly clean all spray mixing and application equipment prior to and following each use. Unless directed otherwise by mixing instructions on the pesticide label, SmartLine AMS Premium Blend should be mixed as follows:

- 1. Fill solution tank one half full of water and begin agitation.
- 2. Add SmartLine AMS Premium Blend to the solution and continue agitation until dissolved. If no mechanical agitation is available, it may be necessary to slurry mix SmartLine AMS Premium Blend in water prior to adding to the tank.
- 3. Add remaining tank-mix products in the following order: dry flowables and water dissolvable granules, wettable powders, flowables, solutions, and emulsifiable concentrates.
- 4. Additional adjuvants as required.
- 5. Continue filling while agitating until all added products are thoroughly mixed into spray solution.

## **IMPORTANT**

## PRECAUTIONARY STATEMENTS

## **FIRST AID**
