Vegetables, Cucurbit Group 9 (See label for list of crops)	Powdery Mildew (<i>Sphaerotheca fuliginea</i> , <i>Erysiphe cichoracearum</i>) Gummy Stem Blight (<i>Didymella bryoniae</i>)	7	Apply preventatively or when conditions are favorable for disease development. Repeat as necessary if conditions are favorable for disease development.	7
